

## Savjetovalište Krnetić


*Savjetovalište Krnetić* je mrežna stranica koja nudi savjetovanje i psihoterapiju za pojedince, parove i grupe i superviziju za stručnjake. Na naslovnoj stranici opisana je povijest *Savjetovališta Krnetić* kao i svrha ove privatne prakse i profesionalna naobrazba. Usluge uključuju terapiju uživo i online putem Skype-a. Kratka povijest online terapije i informacije kako stupiti u kontakt opisani su na stranici Online savjetovanje. Na stranici Prije savjetovanja terapeut savjetuje potencijalne korisnike o tome kako da se informiraju o terapeutu i procesu terapije prije nego što započnu taj proces. Također, nudi se i stranica s odgovorima na najčešća pitanja. Na stranicama Download i Linkovi su brojni pisani materijali i/ili poveznice za teme kao što su depresija, anksioznosti, tretmani, psihoterapijski pristupi (kognitivno bihevioralni, relacionalno-emocionalni), etički kodeksi, popis licenciranih terapeuta BIH. Na stranici Biografija dani su relevantni osobni podaci.

### Opis

Counselling Krnetić (*Savjetovalište Krnetić*) is a web site that offers counselling and psychotherapy for individuals, couples and groups and supervision for professionals. On the main page the history of the Counselling practice is given as well as the purpose of Counselling practice and the educational background. It states that it is the first private practice in Bosnia and Herzegovina. The services offered include in person therapy and online therapy through Skype. A short description of online therapy and info on how to make contact are provided on *Online counselling* page and in Contact page. On *Before counselling* page the therapist advises potential users on how to inform themselves about the therapist or the therapy before they start the process. The potential user is encouraged to ask questions such as: is the therapist a licensed one, does he/she attend regular supervision, what is the agreement on sessions and pricing, etc. Also, unacceptable behaviours from the part of the therapist/counsellor are described (he/she over-exposed personal life and issues, asks the client to meet outside of therapy for private encounters, makes sexual offers, etc. Also, the web site offers section answers on the most common questions ("Do I have to take pills during treatment", "What is the difference between a psychologist and a psychiatrist", etc.). On Download and Links pages, written materials on psychiatric disorders such as depression and anxiety, treatment, and psychotherapy approaches (cognitive behavioural, relational-emotional therapy), codes of ethics, list of licensed psychotherapists in Bosnia and Herzegovina can be found. There are many useful links regarding info on and related to Cognitive-behavioural therapy, Relational-emotional therapy, and Acceptance-commitment therapy. On the Biography page the counsellor/therapist gives an extensive data on education/training and professional affiliation info.
